

# TERMS AND CONDITIONS OF ENTRY

## SOUNDVISION 2017

These Terms and Conditions apply to entry to 'soundvision' (the "Event") operated by La Trobe University (ABN 64 804 735 113) (the "Organiser") to be held on Academic Lawn, La Trobe University, Bundoora, Victoria (the "Venue").

These Terms and Conditions must be read in conjunction with:

- Additional information found on the Organiser's website – <https://50years.latrobe/soundvision> (the "Website");
- Signage at the Venue

By purchasing, obtaining or otherwise using a ticket for the Event, patrons agree to be legally bound by these Terms and Conditions. If you do not accept these Terms and Conditions, you should not purchase or accept a ticket, or attend the Event. The Organiser reserves its rights to alter the Terms and Conditions at any time without notice and it is your duty to check the Website and consult signage at the Venue for posted changes.

## TERMS AND CONDITIONS

Patrons must have a valid Event ticket and are required to present a printed ticket or PDF ticket on your mobile phone for admission to the Venue.

Event tickets are non-transferable. Patrons will be asked to present valid photo identification at the point of entry to the Venue and may be refused entry at the Organiser's discretion if the name on the photo identification does not match that on the Event ticket.

Patrons under 18 years of age must be accompanied by a ticket-holding parent or legal guardian at all times during the Event. Underage patrons who are not accompanied by a ticket-holding parent or legal guardian will be refused entry to the Event and will not be entitled to a refund.

Patrons may be refused entry to the Venue if their ticket is damaged or defaced and will not be entitled to a refund.

The Organiser reserves the right to refuse entry to the Venue or eject any patrons who fail to comply with these Terms and Conditions or any reasonable request of representatives of the Organiser including security staff. The Organiser may also refuse entry to the Venue or eject patrons who are intoxicated, aggressive, disorderly or are exhibiting behaviour that may cause damage, injury or disturbance to other patrons or property. Ejected patrons or patrons refused entry for such reasons will not be entitled to a refund.

The Organiser reserves the right to change the Event program at its discretion without prior notice or compensation to ticket-holders, including without limitation cancelling and replacing any performances, changing the start and finish times of the event and relocating the Event to any other location on the La Trobe University Bundoora campus.

Patrons are required to follow all reasonable directions of Event and security staff at all times.

Patrons acknowledge that they are entering the Event and Venue at their own risk and are responsible for the safety and security of their own person and belongings. The Organiser takes no responsibility for injury, loss or

damage to persons or personal property of patrons. Patrons must not leave any bags or personal items unattended.

To the fullest extent permitted by law, the Organiser does not accept liability of any nature for the acts, omissions or default of the Organiser or of any third parties providing services in connection with the Event or any liability for any death, injury, damage, loss, delay or additional expenses which may be incurred by you at or in association with the Event.

In the event of injury or illness, the Organiser may, at the cost of the patron, arrange medical treatment and/or emergency evacuation as deemed essential for the safety of the patron.

The Venue is a smoke-free zone and smoking (including e-cigarettes) is not permitted.

The Event is an outdoor all weather event and at times may be subject to adverse weather conditions. Cancellation of the Event will occur at the discretion of the Organiser for any reason, including in the case of inclement weather that poses a safety risk to patrons and staff. The Organiser will refund the ticket price to ticket-holders if the Event is cancelled entirely but does not otherwise accept liability for any injury, damage, loss, delay or additional expenses, which may be incurred by patrons as a result of cancellation of the Event.

Patrons' rights to a refund of the ticket price are further set out on the Event page at [Eventbrite](#).

The Venue is fully licenced and consumption of alcohol is strictly prohibited outside the Venue. Proof of age identification is required to buy and consume alcohol and may be requested at any time. Parents and legal guardians are not permitted to buy alcohol for their underage children. Patrons are strictly prohibited from bringing alcohol into the Venue and may be refused entry or ejected if they attempt to do so.

Patrons are not permitted to bring animals into the Venue, unless they are registered assistance animals.

The Organiser reserves the right to search and inspect any patron, bag or property at the time of entry to the Venue or at any other time. Prohibited items will be confiscated and will not be returned. The Organiser may refuse entry to or eject any patron who refuses to submit to a search, or is found in possession of a prohibited item, and such patrons will not be entitled to a refund. Patrons agree to indemnify and hold the Organiser, its officers, employees and agents harmless from any demands, loss, liability, claims or expenses (including consequential loss and legal fees on a full indemnity basis) incurred by the Organiser due to or arising out of the patron's attendance at the Event or any breach by them of these Terms and Conditions.

Audio or visual recordings of the Event are prohibited. Patrons attempting to record the Event may be ejected by the Organiser without refund. Personal cameras are permitted inside the Venue. Any images captured at the Event may only be used for private purposes.

Patrons agree to their inclusion in official photographs, film and audio recordings of the Event and authorise the Organiser or a third party authorised by the Organiser to use, reproduce, communicate and publish those photographs and/or visual and sound recording for advertising or marketing purposes.

The Organiser will only use and disclose personal information for the purpose for which it was collected. Any other type of use and disclosure will require consent, or be in accordance with prescribed exemptions under privacy laws.
